LETTER FROM THE CHAIRMAN

Fiscal Year 2012 marked another record year for the Virginia Department of Alcoholic Beverage Control (ABC)'s Retail Operations Division. Preliminary figures indicate this year ended with \$734 million in gross sales, \$41 million higher than last year, and \$24 million higher than the projected \$710 million target. Retail dollars are up 6.5 percent and mixed beverage licensee dollars are up 4.9 percent. Three new stores that opened this year generated a total of \$1,184,524 in sales.

Commitment to public safety dictates selling responsibly and according to the law. Vigilance by ABC sales associates resulted in an impressive 99 percent compliance rate, up from 98 percent last fiscal year. ABC store employees conduct approximately 2.2 million ID challenges annually while providing service to 27 million buying customers. Accepting donations at the POS register from customers for the Disaster Relief Fund brought in approximately \$188,000 for Virginia tornado victims.

ABC established a Product Management Committee to enhance the agency's abilities to identify and react to rapid changes in the marketplace. The committee established a Supplier Advisory Committee to capture crucial input from vendors.

The Board implemented a reward and recognition program that rewards stores for attainment of exceptional audit reviews utilizing a 125-step program that measures compliance with store operating procedures. A total of 76 stores were recognized this fiscal year.

ABC's Bureau of Law Enforcement developed a Special Operations Unit that serves as a coordinator and command structure for large scale and inter-regional operations. Special Operations established a gang unit to aid in the identification, intelligence gathering and participation in operations concerning criminal street and outlaw motorcycle gangs.

ABC special agents are committed to working with the more than 16,000 licensees and providing compliance training through responsible sellers and servers and manager's alcohol responsibility training.

The bureau began centralizing the retail license application process to reduce processing time and make the initial phase consistent for all applicants statewide. Centralization is scheduled to launch early next fiscal year.

ABC's alcohol education team launched the first ever College Tour, partnering with universities across the state to host a series of one-day regional forums. The Youth Alcohol and Drug Abuse Prevention Project (YADAPP) attracted hundreds of high school leaders dedicated to making a difference in their schools, and Alcohol and Aging Awareness Group (AAAG) continues to provide solutions to substance misuse problems facing older Americans.

Development and implementation of the Leadership and Management Program (LAMP) was a highlight of this fiscal year. The program is designed to build leadership skills and to capture and retain institutional knowledge through its mentoring piece.

Commissioner Bryan M. Rhode was appointed by Governor Robert F. McDonnell in April 2012. He joins Commissioner Sandra C. Canada and me, leading ABC in fulfilling its control, service and revenue mission.

While the 2012 General Assembly did not consider any major groundbreaking alcoholic beverage legislation, it had its usual complement of bills introduced for the benefit of one industry member or another. Several of those enacted are of interest to ABC licensed businesses. Except as noted, each enactment went into effect July 1, 2012.

Outdoor Advertising

One theme, which accounts for four of the enacted measures, was a continuation of the 2011 session's consideration of outdoor alcoholic beverage advertising. In 2011, a last-minute cobbling together of amendments to a mostly unrelated bill resulted in rules governing billboard advertising of alcoholic beverages that failed to satisfy anyone. This year, two identical bills, House Bill 471, sponsored by Delegate David Albo, and Senate Bill 398, introduced by Senator Emmett Hanger, made a number of changes to last year's enactment. The bills more clearly define where alcohol billboards may be located, with a detailed description of the method of measurement to be used to make sure signs are not too close to schools, playgrounds, and places of worship. These bills contained an emergency clause, and became effective April 18, 2012. The same two patrons also introduced House Bill 466 and Senate Bill 408, which merely confirm that all outdoor alcoholic beverage advertising signs in the highway right-of-way must comply with both ABC regulations and those of the Virginia Department of Transportation.

Craft Brewers

Craft brewers, whose numbers are once again on the increase in Virginia, also saw friendly legislation. Senator Jeffrey McWaters sponsored Senate Bill 604, which added additional privileges to the brewery license. Brewers formerly were required to obtain a second license to sell beer for off-premises consumption, and they had to obtain a restaurant license in order to sell beer for on-premises consumption. Under the new law, brewers are able to operate more like a Virginia farm winery, with on- and off-premises sales privileges combined into the brewery license. Delegate Jennifer McClellan introduced House Bill 359, which legalized "contract brewing" arrangements in Virginia. Under the bill, a brewer can manufacture beer and transfer it to another brewer or a wholesaler. This is anticipated to be a boon to start-up breweries who wish to achieve production levels beyond their own manufacturing capacity.

"Motor Sports Facility" License

Virginia's two NASCAR tracks in Richmond and Martinsville are now able to sell mixed beverages throughout the facilities, thanks to identical House Bill 555 and Senate Bill 521, sponsored by Delegate Albo and Senator Frank Wagner, respectively. The bills create a new "annual mixed beverage motor sports facility" license. Formerly, the tracks could only obtain mixed beverage licenses for use within restaurants.

Virginia ABC Stores

Two bills relate to Virginia ABC stores. House Bill 896, also sponsored by Delegate Albo, allows Virginia ABC to open any of its stores statewide after 1 p.m. on Sunday. For several years, ABC stores in Northern Virginia and the cities of Tidewater have been open on Sunday, and more recently the stores of Richmond have seen Sunday openings. Effective

July 1, all the stores were eligible for Sunday operation. Senate Bill 353, introduced by Senator Creigh Deeds, added an additional way for a distillery to qualify to host an ABC store on the distillery property. The new legislation allows ABC to establish a state store at any distillery employing “traditional distilling techniques, including the use of authentic copper pot stills” in any county with a population under 20,000. This description seems to only fit a new distillery under construction in Nelson County.

Underage Buyer Clarification

House Bill 1091 and Senate Bill 406 are two identical bills introduced by Delegate John O’Bannon and Senator Emmett Hanger at the request of the Department of Alcoholic Beverage Control. The two bills make it clear that underage buyers employed for the purpose by the department may purchase and possess alcoholic beverages in the performance of their duties.

Employment of Unauthorized Aliens

Finally, Senate Bill 515, also sponsored by Senator Wagner, provides that the ABC Board may suspend or revoke the license of someone who is convicted of a violation of federal law involving the employment of unauthorized aliens.

Leadership And Management Program (LAMP)

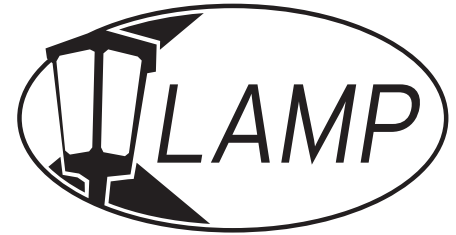
To address the growing number of employees eligible to retire, Virginia ABC launched its comprehensive Leadership And Management Program (LAMP), a high-impact training initiative aimed at developing future ABC leaders.

In the next 10 years, nearly 40 percent of ABC's "Baby Boomer" population will be eligible to retire, and one fifth of the agency's employees in mid- or upper-level management positions could retire. LAMP, a year-long program, was developed to proactively school emerging leaders in three areas: leadership, management and ABC's operating environment. The program requires a one-year commitment from candidates and their managers to be away from the office approximately two days each month for program classes and activities.

Eighteen candidates from divisions across the agency were selected to attend the inaugural ABC LAMP 2011–2012. Participants worked on projects critical to ABC, collaborated in off-site activities and received management-based reading and writing assignments. The program also included networking and mentoring components.

The first LAMP graduates included: William Breitenbach, Financial Management Services; Stephan Brown, Bureau of Law Enforcement; Correne Friesen, Information Technology Services; Russell Cross, Retail Administration; Timothy Cross, Warehouse; Robert Daffron, Retail; Andrew Hallberg, Information Technology Services; Steven Hammond, Policy, Planning and Education; Joseph Hart, Financial Management Services; Susan Johnson, Property Management Services; Joy Reeves, Retail Administration; Charlie Lintecum, Financial Management Services; Kate Matikonis, Bureau of Law Enforcement; Byron Porcher, Policy, Planning and Analysis; Mavis Reid, Retail Administration and Nannette Williams, Internal Audit.

Interviews, selection and programming for the second LAMP cohort was well underway during Fiscal Year 2012. LAMP is expected to be an annual leadership program.

ABC currently employs a diverse workforce, with approximately 980 classified employees, 1,595 wage employees, and 12 contractors. These 2,575 agency employees work throughout the commonwealth operating 338 retail stores and eight regional offices. Approximately 369 employees are located in Richmond at the central office and warehouse facility.

The demographics of ABC's workforce are generally consistent with the overall state workforce. Nearly 74 percent of all employees are over the age of 40, 42 percent are female and 30 percent are minorities. The average age of an ABC classified employee is 47 years, with an average length of service of 11.6 years. ABC has a high number of retirement-eligible classified employees: 106 employees (11 percent of FTE positions) are eligible to retire currently, an additional 47 employees (5 percent FTE positions) within the next five years, and an additional 63 employees (6.5 percent FTE positions) eligible within 10 years.

Management's Discussion and Analysis

(UNAUDITED)

This discussion and analysis of the Virginia Department of Alcoholic Beverage Control's (ABC) financial performance provides a brief overview of financial activities for the fiscal year ended June 30, 2012.

FINANCIAL HIGHLIGHTS

- The Department's operating revenues increased 5.7% in Fiscal Year 2012.
- ABC operations returned record profits to the Commonwealth in Fiscal Year 2012 of \$132.1 million and excise taxes of \$121.1 million. The increase in profits for Fiscal Year 2012 is primarily due to the increase in alcoholic beverage sales.
- Three new stores opened in Fiscal Year 2012 generating \$1.2M in additional sales. Six stores were relocated to improved market areas and nine were remodeled.
- As a result of HB1314 passed by the 2004 session of the General Assembly, the Board was allowed to operate on Sundays. Five additional localities were added to Sunday sales with the passing of HB908 in 2008. Fiscal Year 2012 ended with a total of 133 Stores operating on Sundays. The total Sunday sales for Fiscal Year 2012 reached \$22.0 million, an increase of \$0.9 million from Fiscal Year 2011 to Fiscal Year 2012.
- The Department's operating expenses increased 2.5% in Fiscal Year 2012. The cost of goods sold for alcohol increased \$19.7 million from Fiscal Year 2011, due to the increased sales volume. Personal Service costs increased by 2.2% from Fiscal Year 2011, primarily due to two factors. ABC had increases in employee wage expense directly correlated to the increase in revenue for 2012, and the agency has increased their focus on enforcement. In addition, contractual service costs increased by \$1.4 million primarily due to the use of skilled services for IT staff augmentation, additional VITA costs, and increases in building repair costs.

OVERVIEW OF FINANCIAL STATEMENTS

The audited annual report consists of a series of proprietary fund financial statements. The Statement of Net Assets provides information about the Department's assets and liabilities and reflects the financial position as of June 30, 2012. The Statement of Revenues, Expenses, and Changes in Net Assets reports the operating revenue activity and the expenses related to such activity for the twelve-month period ended June 30, 2012. The Statement of Cash Flows outlines the cash inflows and outflows relating to the operations for the same twelve-month period. The financial statements also include "notes" that provide additional information that is essential to a full understanding of the data provided in the statements. These statements provide current and noncurrent information about the Department's financial position.

FINANCIAL ANALYSIS

- ABC ended Fiscal Year 2012 with a total of \$58.0 million in current assets including \$47.1 million in inventory of alcohol merchandise for resale, a \$0.3 million increase. The increase in inventory is a result of 3 new stores being opened in Fiscal Year 2012, new products being introduced in the market and vendor price increases to ABC. Current assets were also impacted by an increase of \$2.2 million in credit card accounts receivable due to statewide power outages that occurred on June 29 and 30 that delayed credit card processing and therefore increased receivables.
- The change in Net Capital Assets from Fiscal Year 2011 to Fiscal Year 2012 is due to additional costs spent in Fiscal Year 2011 for the Point of Sale (POS) hardware and software.
- In total, assets increased from \$66.6 million in Fiscal Year 2011 to \$68.0 million in Fiscal Year 2012.

- Total liabilities owed by the Department increased \$1.4 million from last fiscal year, with current liabilities representing \$1.2 million of the total amount. The current liability amount is largely represented in accounts payable as well as payments due to the Commonwealth for line of credit repayment, taxes payable (see Note 4) and the undistributed balance of profits. Excise Tax Payable increased \$1.7 million, primarily due to the above mentioned statewide power outages. This was offset by a (\$1.0) million reduction in the Commonwealth's line of credit. The remainder was primarily due to an increase in undistributed profits over the prior year. Noncurrent liabilities netted a slight increase.
- The Department lacks working capital (current assets in excess of current liabilities) to fund all business needs at year-end including accelerated payments of taxes and profits before June 30. Given this periodic lack of necessary working capital, the Department depends on a \$60.0 million line of credit with the State Comptroller to meet day-to-day operations. At June 30, 2012, the amount borrowed was \$28,488,757. (see Note 4)

REVENUE: The vast majority of the Department's revenues come from the sale of alcoholic beverages. These revenues are achieved through the 330+ state-run stores located throughout the state. Gross sales including state tax on sales in Fiscal Year 2012 reached an all time high of \$733.8 million, up \$41.1 million over Fiscal Year 2011. The gross revenue after state tax on sales of alcohol increased from \$578.5 million to \$612.7 million or 5.9%. License and permit fees slightly decreased in Fiscal Year 2012 totaling \$12.0 million and \$12.1 million in Fiscal Year 2011. Federal grants and contracts, miscellaneous revenue and penalties decreased from last year. Other sources of revenue include lottery, wine wholesalers tax and mixed beverage taxes on common carriers.

EXPENSES:

In Fiscal Year 2012 operating expenses (not including cost of sales, alcohol and lottery) increased from \$137.7 million to \$141.2 million, an increase of 2.5%. Approximately 71.3% of the Department's total expenses are for the cost of sales of distilled spirits and mixers sold through ABC stores and less than 1.0% for lottery cost of sales. Following cost of merchandise is personal services, which accounts for 16.6% of total expenses. The remaining 11.6% is made up of contractual services (e.g. store rents), continuous charges (utilities) and other miscellaneous charges. Personal service costs increased primarily due to two factors. ABC had increases in employee wage expense directly correlated to the increase in revenue for 2012, and the agency has increased their focus on enforcement. The increased cost of contractual services is due to the use of skilled services for IT staff augmentation, additional VITA costs and increases in building repair costs. Depreciation expense decreased due to the Warehouse Racking & Conveyor project was fully depreciated in July 2011.

PROFITS:

Prior to the statutory distribution of quarterly net profits to the General Fund, transfers required in the Appropriation Act for each fiscal year must be executed. In Fiscal Year 2012, approximately \$67.9 million of the agency's \$132.1 million in net profits were transferred to other state agencies. The majority, \$65.4 million, transfers to the Department of Behavioral Health and Developmental Services incurred for care, treatment, study and rehabilitation of alcoholics. The remaining \$64.2 million was distributed to the General Fund in accordance with the Code of Virginia.

ECONOMIC FACTORS AND NEXT YEAR'S BUDGET

- During Fiscal Year 2013, the Department expects the retail sales sector to remain strong and will continue to monitor mixed beverage licensee sales. ABC is currently forecasting gross sales of \$758 million, a 3.3% increase over Fiscal Year 2012.
- ABC expects expenses to continue to increase in Fiscal Year 2013. Expenses such as store rents will increase because of contractual escalation clauses. The Department also projects increases in non-merchandise expenditures, which includes product shipping to stores and on-going infrastructure improvements in order to comply with data security standards mandated for credit card payments. The payment of a 3% bonus to classified employees will increase personal service costs by an estimated \$1.4M. ABC also expects an increase in technology charges for maintenance of existing operation systems to the VITA /NG partnership as a result of rate changes.
- Appropriation Act profit transfer requirements for Fiscal Year 2013 are \$124.9 million. ABC expects to meet this transfer requirement. Risks included economic declines, particularly during the holiday season and unforeseen increases in expenses.

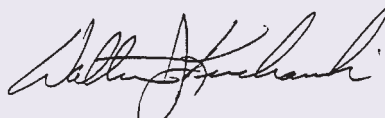

In our opinion, the financial statements referred to previously present fairly, in all material respects, the financial position of the Department of Alcoholic Beverage Control as of June 30, 2012, and the changes in its financial position, and its cash flows for the year ended, in conformity with accounting principles generally accepted in the United States of America.

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis on pages 27 through 30 be presented to supplement the basic

financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

In accordance with Government Auditing Standards, we have also issued our report dated September 28, 2012 on our consideration of the Department of Alcoholic Beverage Control's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts and grant agreements, and other matters. We anticipate releasing that report on or after October 4, 2012. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards and should be considered in assessing the results of our audit.

NOTES TO FINANCIAL STATEMENTS

AS OF JUNE 30, 2012

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Reporting Entity

The Department of Alcoholic Beverage Control administers ABC laws with an emphasis on public service and a focus on public safety by ensuring a safe, orderly, and regulated system for convenient distribution and responsible consumption of alcoholic beverages while generating a reasonable profit for the Commonwealth.

A separate report is prepared for the Commonwealth of Virginia, which includes all agencies, boards, commissions, and authorities over which the Commonwealth exercises or has the ability to exercise oversight authority or is the recipient of their services and/or benefits. The Department is an agency of the Commonwealth of Virginia and is included in the Commonwealth of Virginia's Comprehensive Annual Financial Report.

B. Fund Accounting

The activities of the Department are accounted for in an enterprise fund. The enterprise fund is used to account for operations that are financed and operated in a manner similar to private business enterprises where the intent of the governing body is that the costs of providing goods and services to the general public on a continuing basis, including depreciation and amortization, be financed or recovered primarily through user charges.

C. Basis of Accounting

The Department's records are maintained on the accrual basis, with an economic focus, whereby revenues are recognized when earned and expenses are recognized when the liability is incurred.

Operating revenues and expenses include activities related to the sale of alcohol and licenses, as well as enforcement activities. Nonoperating revenues and expenses include activities that have the characteristics of noncapital financing activities, such as the collection of rent, as defined by GASB Statement 9, *Reporting Cash Flows of Proprietary and Nonexpendable Trust Funds and Governmental Entities That Use Proprietary Fund Accounting*, and GASB Statement 34.

D. Inventories

Merchandise inventory, purchased for resale, is valued at average cost, which is lower than market value.

2. CASH WITH THE TREASURER OF VIRGINIA

All state funds of the Department are held by the Treasurer of Virginia, pursuant to Section 2.2-1800, et. seq., Code of Virginia, who is responsible for the collection, disbursement, custody, and investment of state funds. Each fund's equity in pooled state funds is reported as "Cash and Cash Equivalents" on the Statement of Net Assets and is not categorized as to credit risk.

The Department capitalizes all property, plant, and equipment that have a cost or value equal to or greater than \$5,000. The Department capitalizes all intangibles that have a cost or value equal to or greater than \$100,000. Property, plant, equipment, and intangibles are stated at cost and at the time of acquisition are set up in a comprehensive capital asset system. Depreciation of the cost of property, plant, equipment, and intangibles are provided on a straight-line basis over their estimated lives of from ten to thirty years on buildings, from three to eight years on equipment, and from three to five years on intangibles. Intangible

assets are defined as assets that lack physical substance, are non-financial in nature and useful lives or benefit period exceed one or more years. Examples of intangible assets are: software, land use rights (right-of-ways) and intellectual property (patents, copyrights and trademarks).

4. DUE TO THE COMMONWEALTH

A. Note Payable

The Department has a line of credit for \$60,000,000 with the Treasurer of Virginia. Repayment is made from revenue collections pursuant to Title 4.1, Chapter 1 of the Code of Virginia. As of June 30, 2012, the Department had outstanding \$28,488,757 of its available line of credit to extinguish a cash overdraft.

B. General Fund

The Department collects certain taxes on behalf of the General Fund of the Commonwealth. The state tax on sales is collected from store sales and is paid quarterly to the General Fund of the Commonwealth. The liter tax is collected on wholesalers' direct wine shipments. The 2012 Virginia Acts of Assembly required \$9,141,363 of the gross liter tax to be transferred to the General Fund for expenses incurred for care, treatment, study, and rehabilitation of alcoholics by the Department of Behavioral Health and Development Services and other state agencies. Of the remaining liter tax, twelve percent is retained by the Department and reported as wine wholesalers' tax on the Department's financial statements. The remaining eighty-eight percent is paid to the General Fund of the Commonwealth quarterly. Collections and transfers of state tax on sales and liter tax are not reported on the Statement of Revenues, Expenses, and Changes in Net Assets. Activity relating to the amounts due to the General Fund for the year ended June 30, 2012, is summarized below.

C. Department of Taxation - Sales Tax

The Department collects sales tax on all sales of alcohol and remits collections monthly to the Department of Taxation. Sales tax collections and transfers are not reported on the Statement of Revenues, Expenses, and Changes in Net Assets. Activity relating to the amounts due to the Department of Taxation for the year ended June 30, 2012, is summarized below.

D. Earned Surplus

The Appropriation Act, Chapter 2 of the 2011 Acts of Assembly, requires the Department to transfer an estimate of its fourth quarter profits in the month of June. In accordance with the Alcoholic Beverage Control Act, Section §4.1-116 of the Code of Virginia, the Department transfers any additional net profit to the General Fund of the Commonwealth 50 days after the last day of the quarter. The Department underestimated profit for the fourth quarter resulting in an additional \$7,078,691 due to the General Fund at June 30, 2012.

5. LEASE COMMITMENTS

The Department is committed under various operating lease agreements for retail store buildings. Rent expense under operating lease agreements amounted to \$ 20,861,551 for the year. A summary of future obligations under lease agreements as of June 30, 2012, follows.

6. COMPENSATED ABSENCES

Compensated absences reflected in the Statement of Net Assets represent the amounts of vacation, sick, and compensatory leave earned by employees of the Department, but not taken at June 30, 2011. The amount reflects all earned vacation, sick, and compensatory leave payable under the Commonwealth of Virginia's leave payout policies. Information on the Commonwealth's leave payout policies is available at the statewide level in the Commonwealth of Virginia's Comprehensive Annual Financial Report.

7. SECURITIES LENDING TRANSACTIONS

Investments held by the Treasurer of Virginia represent the Department's allocated share of cash collateral received and reinvested and securities received for the State Treasury's securities lending program. Information related to the credit risk of these investments and the State Treasury's securities lending program is available on a statewide level in the Commonwealth of Virginia's Comprehensive Annual Financial Report. The Commonwealth's policy is to record unrealized gains and losses in the General Fund in the Commonwealth's basic financial statements. When gains or losses are realized, the actual gains and losses are recorded by the affected agencies.

8. COLLECTIONS OF MALT BEVERAGE TAX

During the year ended June 30, 2012, the Department collected \$43,660,370 in malt beverage taxes. These funds are deposited by the Department directly with the Treasurer of Virginia for credit to the General Fund of the Commonwealth and are not available to the Department to meet current operating needs and are not included in the financial statements.

9. PENSION PLAN AND OTHER POST RETIREMENT BENEFITS

The employees of the Department are employees of the Commonwealth. The employees participate in a defined benefit plan administered by the Virginia Retirement System (VRS). The VRS also administers life insurance and health related plans for retired employees. Information related to these plans is available on a statewide level only in the Commonwealth of Virginia's Comprehensive Annual Financial Report. The Commonwealth, not the Department, has overall responsibility for contributions to these plans.

10. RISK MANAGEMENT

The Department is exposed to various risks of loss related to torts; theft or, damage to, and destruction of assets; errors and omissions; non-performance of duty; injuries to employees; and natural disasters. The Department of Alcoholic Beverage Control participates in insurance plans maintained by the Commonwealth of Virginia. The state employee health care and worker's compensation plans are administered by the Department of Human Resource Management and the risk management insurance plans are administered by the Department of Treasury, Division of Risk Management. Risk management insurance includes property, general liability, medical malpractice, faithful performance of duty bond, automobile, and air and watercraft plans. The Department of Alcoholic Beverage Control pays premiums to each of these Departments for its insurance coverage. Information relating to the Commonwealth's insurance plans is available at the statewide level in the Commonwealth of Virginia's Comprehensive Annual Financial Report.

11. CONTINGENT LIABILITIES

Legal Proceedings

The Department is named as a party in several legal proceedings. It is not possible at the present time to estimate ultimate outcome or liability, if any, of the Department in respect to the various proceedings; however, it is believed that any ultimate liability resulting from these suits will not have a material, adverse effect on the financial condition of the Department.

Bailment Inventory

The Department houses and controls bailment inventory in the warehouse and is therefore responsible for the exercise of reasonable care to preserve the inventory until it is purchased by the Department or returned to the supplier. The Department uses the bailment system for payment of merchandise for resale. The Department initiates payments to the vendors based on shipments from the ABC warehouse to the retail stores, rather than receipt of invoice from the vendor. At June 30, 2012, the bailment inventory was valued at \$37,067,552.

FISCAL YEAR 2012 IN REVIEW

EXPANDED SUNDAY SALES

Beginning Sunday, July 1, the agency expanded Sunday hours to its remaining 206 stores throughout the state. The additional stores were able to open on Sundays as a result of the passage of House Bill 896 during the 2012 legislative session. The new law allows any ABC retail location to be open on Sundays. Sunday hours are 1–6 p.m.

SPIRITED ENTERTAINING

In October 2011, the agency launched spiritedentertaining.com, its first .com site. The micro site contains nearly 100 unique drinks in themed categories.

DISASTER RELIEF FUND PROJECT

In support of the Governor's initiative, the agency implemented functionality to accept donations at the POS register from customers for victims of the devastating tornadoes in Virginia. By November 1, ABC customers donated \$187,733.10 towards this effort.

ENFORCEMENT RESPONDS TO CHANGING NEEDS

Noting an increase in the number of major and complex investigative activities such as illegal distilleries, nip joints, human trafficking, and problem establishment investigations, the Bureau of Law Enforcement established two new units. The Gang Unit aids in the identification, intelligence gathering and participation in operations concerning criminal street and outlaw motorcycle gangs. The Special Operations Unit serves as the coordinator (and in many cases) the command structure for large-scale and inter-regional operations. This unit also serves as the facilitator for resource consolidation for regionally based operations.

LISTENING TO THE INDUSTRY

The agency chartered a Product Management Committee (PMC) to provide procedurally valid recommendations to the ABC Board concerning the management of products available for sale in state stores. In similar fashion, the agency also developed a Supplier Relations Committee to provide a process to gather feedback from our vendor partners.

STORE COMPLIANCE RATES

Vigilance by ABC sales associates resulted in an impressive 99 percent compliance rate, up from 98 percent last fiscal year.

BLACK FRIDAY SALES

The agency tested the waters on this traditionally high volume retail shopping day by offering 25–50 percent discounts on selected items as well as 10 percent off any purchase totaling \$50 or more. Total sales for this day saw a \$398,000 increase.

SECURITY DETECTION

The Information Technology Division fortified remediation baselines set for all internally developed applications making ABC the only agency in the commonwealth that runs security vulnerability detection software against its applications.

ONLINE LICENSEE ORDERING

ABC's Retail and Information Technology divisions developed another avenue for licensees to place their orders more efficiently online. Process includes the ability to view accurate, up-to-date product codes with present and future discounting, along with automatic email notifications when their order has been submitted and is ready for pick up.

LEADERSHIP PROGRAM

The agency launched its Leadership and Management Program (LAMP). The initiative is designed to build leadership skills and to foster a culture conducive to the forward movement of ABC. Through its mentoring aspect, LAMP strives to capture and retain institutional knowledge imparted by those who serve as mentors. (See page 7 of this annual report for more information.)

EDUCATION INITIATIVES

The agency continued its education/prevention initiatives by hosting College Tour, a three-stop college program including Norfolk State, Longwood and George Mason universities. In its outreach to high school students, ABC attracted 340 youth participants from schools and communities across the commonwealth to its annual summer leadership conference, Youth Alcohol and Drug Abuse Prevention Project (YADAPP).
