AUDIT SUMMARY

This statewide report summarizes the findings from our audit of the District Court System for the fiscal year ended June 30, 2021. Our audits resulted in findings in 58 courts, some of which had multiple findings. This is an increase from 49 courts with findings in the prior year. The most common finding was related to the proper billing and collection of court fines, costs, and restitution. Other findings were related to compliance with requirements for tax set-off, unclaimed property, bond forfeiture, and local and state revenue remittance. We also noted internal control weaknesses in accounting areas such as improper record retention, delayed bank deposits, lack of bank reconciliation, inadequate review of internal reports, improper monitoring and disbursement of liabilities, and improper management of system access. Twenty-one of the District Court audits had repeat findings compared to 12 courts with repeat findings in the prior year. Two of the Juvenile and Domestic Relations District courts, Franklin County and Pittsylvania have received the same finding since fiscal year 2016.

The potential financial impact of these findings are state revenue losses of approximately \$101,100, locality revenue losses of approximately \$9,000, courts overcharging defendants by approximately \$9,200, and tax set-off losses of \$32,100.



INTERNAL CONTROL AND COMPLIANCE FINDINGS SUMMARY


For the year ended June 30, 2021, we completed 211 District Court audits, 114 of which were comprehensive audits and 97 of which were limited control reviews. A comprehensive audit involves audit procedures designed to review, in detail, areas such as revenues, expenditures, system access security, accounts receivable, and liability management. A limited control review involves the completion of an internal control questionnaire and some limited audit procedures based on the results of the questionnaire. Limited control reviews are only performed on courts that have been considered low risk based on the results of previous audits and an overall assessment of the individual court environment. An <u>Appendix</u> is included following this section that contains a summary of the District Court audit results by locality and court type. As shown in Chart 1 below, our audits identified findings in 58 courts, some with multiple findings including six in Fauquier GDC. This is an increase from 49 courts with findings in the prior year.






Our analysis of the cumulative results of the audits identified several recurring trends across the Commonwealth. Of the 87 management recommendations made, 56 percent addressed the proper billing and collecting of court fines, costs, and restitution. The potential financial impact of these weaknesses are state revenue losses of approximately \$101,100, locality revenue losses of approximately \$9,000, and courts overcharging defendants by approximately \$9,200. Chart 2 below shows the distribution of the potential loss of state revenue by court type.

An additional ten findings (12%) identified possible tax set-off (TSO) losses of \$32,100. Chart 3 below shows the distribution of potential tax set-off losses by court type.


Potential Tax Set-Off Losses by Court Type



In addition to issues with billing and collection and tax set-off, as shown in Chart 4 below, internal control weaknesses and compliance issues noted in other accounting areas include improper record retention, timely deposit and remittance of funds, and lack of bank reconciliations. The finding areas have remained fairly consistent with the prior year. A complete list of findings is included in the Appendix to this report.


Finding Areas





Twenty-one of the District Court audits had repeat findings compared to 12 courts with repeat findings in the prior year. Two of the courts, Franklin County JDR and Pittsylvania JDR, have received the same finding since fiscal year 2016.
