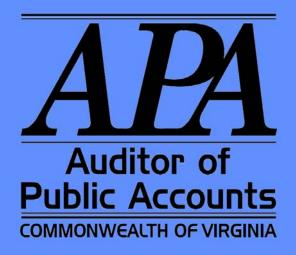

Independent Auditor's Report

We have examined the accompanying Treasurer Turnover Receipts of Assets of Jennifer J. Brown, Treasurer of the City of Charlottesville, at September 30, 2012. The examination was performed to determine the accountability of the Treasurer at September 30, 2012 and to turn over the assets, accounts, and records of the office to Jason Vandever, the newly appointed Treasurer.
