We are performing a statewide audit of the Juvenile and Domestic Relations District Courts. During our review of this court, we conducted certain audit procedures, as we deemed appropriate.

Management of this court is an important part of the court's accountability, since you are responsible for establishing and maintaining internal controls and complying with applicable laws and regulations. During our review, we noted certain matters that required management's attention and corrective action. These matters included:

Reconcile Bank Account (new finding)

The Clerk did not reconcile the court's bank account during the audit period. Timely and complete reconciliations are an essential internal control. Allowing reconciling items to go unresolved can lead to errors and irregularities going undetected and increases the risk of loss of funds.

The Clerk should perform monthly bank reconciliations upon receiving the bank statements as required by the Financial Management System User's Guide.

Properly Bill and Collect Court Costs (repeat finding)

The Clerk and her staff did not properly bill and collect court costs. In five of 14 cases tested, we noted the following errors.

- In five cases, the Clerk did not bill the defendants for public defender fees of \$600 and court costs of \$172, resulting in a loss to the Commonwealth and Locality
- In one case, the Clerk did not bill the locality for attorney fees of \$120, resulting in a loss to the Commonwealth

The Clerk and her staff should correct the specific cases noted above and should establish a system of review to minimize the likelihood of billing errors going undetected. In all cases, the Clerk should bill and collect court costs in accordance with Code of Virginia.

Properly Assess DNA Fees (new finding)

The Clerk is not utilizing information available through the Local Inmate Data System (LIDS) to determine whether or not a defendant needs to have a DNA sample taken, the cost of which the defendant must pay. Section 19.2-310.2 of the Code of Virginia requires defendants to pay for the taking of DNA samples when convicted of felonies and certain misdemeanor offenses. However, the defendant is not required to pay if a sample has already been obtained on previous convictions, and this is determined through information available in LIDS. The Clerk should obtain access to LIDS in order determine if DNA has already been taken from a defendant and assess the DNA fee as appropriate.

Request Tax Set-Off Refunds (new finding)

The Clerk did not submit claims to the Virginia Department of Taxation (Taxation) for tax set-off of refunds for delinquent court costs and fines totaling \$174, resulting in a loss of revenue to the Commonwealth and Locality. A court must submit claims for set-off of tax refunds through Taxation's automated accounting system, the Integrated Revenue Management System. The Clerk should use the tax refund set-off process to maximize collections as required by the Code of Virginia.

Properly Review General Ledger (new finding)

The Clerk does not properly review the Court's general ledger to ensure account balances are appropriate. Account code 107, which is an account that is not applicable in juvenile and domestic relations courts, has had a negative balance of \$75 since fiscal year 2014.

The Clerk should monitor the Court's General Ledger monthly for appropriate accounts, balances and activity and immediately correct any discrepancies per the Financial Management User's Guide.
