#### **AUDIT SUMMARY**

This statewide report summarizes the findings from our audit of the District Court System for the fiscal year ended June 30, 2022. Our audits resulted in findings in 50 courts, some of which had multiple findings. This is a decrease from 58 courts with findings in the prior year. The most common finding was related to the proper billing and collection of court fines, costs, and restitution. Other common findings were related to compliance with requirements for tax set-off and state revenue remittance. We also noted internal control weaknesses in accounting areas such as improper record retention, delayed bank deposits, and lack of bank reconciliations. Twenty of the District Court audits had repeat findings compared to 21 courts with repeat findings in the prior year. One of the courts, Pittsylvania Juvenile and Domestic Relations District Court has received the same finding since fiscal year 2016 and two other courts, Prince George Combined District Court and Prince William General District Court have received the same findings since fiscal year 2017.

The approximate potential financial impact of these findings are state revenue losses of \$82,700, locality revenue losses of \$8,600, courts overcharging defendants by \$13,300, and tax set-off losses of \$56,000. These amounts are based on actual errors noted within our samples of court transactions, the impact of which is not projected to all transactions of the courts.


We are pleased to submit our **Statewide Report on Virginia District Court System Audits** for the fiscal year ended June 30, 2022. The Auditor of Public Accounts annually audits each General District Court (GDC), Juvenile and Domestic Relations District Court (JDR), and Combined District Court (CDC) to determine whether they have maintained accountability over Commonwealth and locality collections, established adequate internal controls, and complied with state laws and regulations. This statewide report summarizes the findings we have previously communicated to the individual Chief Judges, Presiding Judges, Clerks, and the Director of Judicial Services at the Office of the Executive Secretary of the Supreme Court of Virginia upon completing our individual audits. #### INTERNAL CONTROL AND COMPLIANCE FINDINGS SUMMARY


For the year ended June 30, 2022, we completed 210 District Court audits, 112 of which were comprehensive audits and 98 of which were limited control reviews. A comprehensive audit involves audit procedures designed to review, in detail, areas such as revenues, expenses, system access security, accounts receivable, and liability management. A limited control review involves the completion of an internal control questionnaire and some limited audit procedures based on the results of the questionnaire. Limited control reviews are only performed on courts that have been considered low risk based on the results of previous audits and an overall assessment of the individual court environment. An <a href="Appendix">Appendix</a> is included following this section that contains a summary of the District Court audit results by locality and court type. As shown in Chart 1 below, our audits identified findings in 50 courts, some with multiple findings including five in Campbell JDR and four in Emporia CDC. This is a decrease from 58 courts with findings in the prior year.



Our analysis of the cumulative results of the audits identified several recurring trends across the Commonwealth. Of the 78 management recommendations made, 54 percent addressed the proper billing and collecting of court fines, costs, and restitution. The approximate potential financial impact of these weaknesses are state revenue losses of \$82,700, courts overcharging defendants by \$13,300, and locality revenue losses of \$8,600. These amounts are based on actual errors noted within our samples


of court transactions, the impact of which is not projected to all transactions of the courts. Chart 2 below shows the distribution of the potential loss of state revenue by court type.

**Potential Loss of State Revenue by Court Type** 




An additional ten findings (13%) identified possible tax set-off (TSO) losses of \$56,000. Chart 3 below shows the distribution of potential tax set-off losses by court type.

**Potential Tax Set-Off Losses by Court Type** 




In addition to issues with billing and collection and tax set-off, as shown in Chart 4 below, internal control weaknesses and compliance issues noted in other accounting areas include timely deposit and remittance of funds, improper record retention, and lack of bank reconciliations. The finding areas have remained fairly consistent with the prior year. A complete list of findings is included in the <a href="Appendix">Appendix</a> to this report.



Twenty of the District Court audits had repeat findings compared to 21 courts with repeat findings in the prior year. One of the courts, Pittsylvania Juvenile and Domestic Relations District Court has received the same finding since fiscal year 2016 and two other courts, Prince George Combined District Court and Prince William General District Court have received the same findings since fiscal year 2017.
