We are performing a statewide audit of the Combined General District Courts. During our review of this court, we conducted certain audit procedures, as we deemed appropriate.

Management of this court is an important part of the court's accountability, since you are responsible for establishing and maintaining internal controls and complying with applicable laws and regulations. During our review, we noted certain matters that required management's attention and corrective action. These matters included:

Properly Bill and Collect Court Costs and Fines

Both the previous and current Clerk did not properly bill and collect court costs and fines resulting in a loss of revenue to the Commonwealth and locality. In 11 of 50 cases tested, the auditor noted the following errors.

- In four cases, the Clerk did not bill defendants for court appointed attorney fees of \$473, resulting in a loss to the Commonwealth.
- In three cases, the Clerk did not certify \$203 of court costs to the Circuit Court, resulting in a loss to both the Commonwealth and locality.

- In three cases, the Clerk miscoded the court-appointed attorney fees of \$ 360 as state fees instead of local fees, resulting in a loss to the locality.
- In one case, the Clerk miscoded a fine of \$100 as local instead of state, resulting in a loss to the Commonwealth.
- In one local case, the Clerk incorrectly billed the Commonwealth instead of the locality for courtappointed attorney fees, which paid \$120.
- In one state case, the Clerk incorrectly billed the locality instead of the Commonwealth for courtappointed attorney fees, which paid \$120.
- In one case, the Clerk incorrectly entered the charge as a local offense instead of a state offense in the court's automated information system.

The Clerk should correct these specific cases noted above. Further, the Clerk should bill and collect court costs and fines in accordance with the <u>Code of Virginia</u>.
